

OFFICIAL SWEEPSTAKES RULES

1. INTRODUCTION

Sony Nashville ("Sponsor") is offering the **Danny Gokey flyaway** ("Sweepstakes"). **NO PURCHASE OR OBLIGATION IS NECESSARY.** By entering this Sweepstakes, entrants agree to abide by all terms of these Official Sweepstakes Rules and the decisions of Dial Global ("Sweepstakes Administrator") and Sponsor, whose decisions shall be final and binding. **VOID WHERE PROHIBITED.**

2. ELIGIBILITY

This Sweepstakes is open only to individuals who are **21 years of age or older** and legal residents of the United States at the time of entry. Individuals who have already won/qualified from the Sweepstakes Administrator twice in the month of March 2010 are NOT eligible to qualify/win. To enter, participants must call in to the 800 phone number announced during broadcasts of the "Hot Country" program (the "Program") during the Sweepstakes Period and sing the next line of a provided song. Another way to enter is to log on to www.newhitcountry.com and submit an entry. We are not responsible for any technical malfunctions that may occur.

4. WINNER SELECTION

Odds of winning depend on the total number of phone call and email entries.

One (1) grand prize winner is selected from all entries.

Grand prize drawing will be conducted by an impartial representative of Sweepstakes Administrator.

Grand prize winner will be selected and announced on March 26, 2010.

Each Hot Country affiliate radio station that choose to solicit calls directly to its own local telephone number for this sweepstakes may submit one grand prize entry per local day part, per day, during the Sweepstakes Period (for example, a local affiliate airing a local program during 2 day parts Monday through Friday is allowed 10 grand prize entries each week for a total of 20 grand prize entries during the Sweepstakes Period).

In addition, each Hot Country affiliate radio station that chooses to collect entries at local live remote broadcasts may submit five entries per remote (no more than two remotes during this Sweepstakes Period) during the duration of the promotion. Local radio station affiliates are responsible for awarding runner-up prizes, if any, to its own grand prize entrants for this Sweepstakes.
