

## **OFFICIAL SWEEPSTAKES RULES**

### **1. INTRODUCTION**

Arista Nashville ("Sponsor") is offering the **Brad Paisley Promotion** ("Sweepstakes"). **NO PURCHASE OR OBLIGATION IS NECESSARY.** By entering this Sweepstakes, entrants agree to abide by all terms of these Official Sweepstakes Rules and the decisions of Dial Global ("Sweepstakes Administrator") and Sponsor, whose decisions shall be final and binding. **VOID WHERE PROHIBITED.**

### **2. ELIGIBILITY**

This Sweepstakes is open only to individuals who are **21 years of age or older** and legal residents of the contiguous United States at the time of entry. Individuals who have already won/qualified from the Sweepstakes Administrator twice in the month of July 2009 are NOT eligible to qualify/win. ### **3. HOW TO ENTER**

The Sweepstakes begins at 2:00 a.m. EST on July 6, 2009 and ends at 03:00 p.m. EST on July 23, 2009 ("Sweepstakes Period"). There are two ways to enter. One is to log on to: [www.newhitcountry.com](http://www.newhitcountry.com) and submit and online entry. The second way is to qualify on the air when prompted to do so. We are not responsible for any technical malfunctions that may occur.

### **4. WINNER SELECTION**

Fifty (50) on-air and email entries will be qualified for the grand prize on the network.

Odds of winning depend on the total number of phone and online entries.

Only one (1) winner per household.

Grand prize drawing will be conducted by an impartial representative of Sweepstakes Administrator.

Grand prize winner will be selected and called on July 24, 2009.

Grand prize winner will be announced on the air on July 24, 2009.

Each Hot Country radio station affiliate that chooses to solicit calls directly to its own local telephone number for this sweepstakes may submit one grand prize entry per local day part, per day, during the Sweepstakes Period (for example, a local affiliate airing a local program during 2 day parts Monday through Friday is allowed 10 grand prize entries each week for a total of 20 grand prize entries during the Sweepstakes Period).

In addition, each Hot Country radio station affiliate that chooses to collect entries at local live remote broadcasts may submit five entries per remote (no more than two remotes during this Sweepstakes Period) during the duration of the promotion. Local radio station affiliates are responsible for awarding runner-up prizes, if any, to its own grand prize entrants for this Sweepstakes.

Local qualifier names must be submitted to the sweepstakes administrator no later than 5 PM EST on Thursday, July 23, 2009.
